In the event of a leak, AguaSeal undertakes to provide sufficient manufacturer's product, and the necessary labor at no cost, to remedy the defect, so long as any leaks are not the result of outside influences such as building settlement, structural defects, mechanical causes, unauthorized work on the roof, acts of God and failure to properly maintain your roof.

Further, in the event of excessive peeling, cracking or delamination, if any, AguaSeal will pay for the labor and material to correct such condition, even if the condition does not lead to a leak, so long as such condition does not stem from a failure to properly maintain the roof.

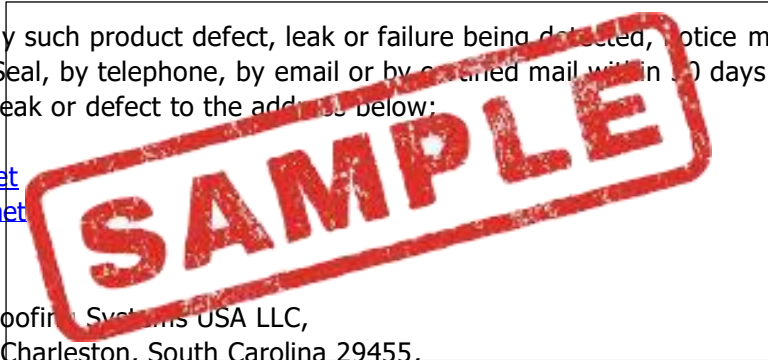
This shall be the sole remedy under this product warranty.

Within 3 days of receipt of notice, or as soon as practical, AguaSeal will evaluate the situation and provide a prompt response Upon receipt of such notice, AguaSeal will, as soon as practical, evaluate the situation and provide a prompt response to owners request under this warranty.

Failure to advise AguaSeal within the 30 days following detection of the defect will effectively terminate AguaSeal's responsibility to evaluate and authorize replacement of product and any necessary repairs deemed necessary by AguaSeal's evaluation under this warranty. This does not void the warranty as it relates to future repairs unrelated to the time barred claim.

In the event that AguaSeal approves any repairs at no cost to the owner, that are not otherwise covered under this warranty, AguaSeal does not waive any rights to enforce the terms of this warranty for any future claims, even if they are similar claims.

It is specifically agreed that AguaSeal is not liable nor shall it be held liable beyond replacing defective products and covering reasonable labor costs related to the claim made under this warranty.

This warranty covers the AguaSeal products provided and no other warranty is expressed or implied. No party has the authority to alter, change, modify or extend this product warranty without the express written approval of AguaSeal.

If the owner(s) sell or otherwise transfer the building this warranty is transferrable to new owner(s) upon written application, by email or by mail, to AguaSeal, within 30 days of transfer of the building. Upon expiration of this warranty it may be renewed for an additional 10 years, so long as the roof is properly power washed and a minimum of 2 additional finish coats are applied.

THIS WARRANTY PROVIDES THE BUILDING OWNER(S) SOLE REMEDY AT LAW OR IN EQUITY, WHETHER BASED ON CONTRACT WARRANTY, NEGLIGENCE OR ANY OTHER STATUTORY OR COMMON LAW THEORY.
